

DINNER FOR A YEAR OFFICIAL RULES  
NO PURCHASE NECESSARY TO ENTER

OPEN TO LEGAL RESIDENTS OF THE UNITED STATES (EXCLUDING PUERTO RICO THE U.S. VIRGIN ISLANDS, AND OTHER COMMONWEALTHS, TERRITORIES, AND POSSESSIONS), 21 YEARS OR OLDER.

1. By entering this CONTEST (the "Contest") and accepting the terms herein, you agree to be bound by the following rules ("Official Rules"), which constitute a binding agreement between you, on one hand, and TASTY EXPO, on the other.
